Once you are pre-enrolled to be fingerprinted you MUST bring a printed copy of the barcode/ tracking number with you. If the barcode /tracking number does not accompany the fingerprints we will NOT be able to accept the application. Please note that once you complete the pre-enrollment process and pay online there are NO refunds.
